FOOTNOTE: OVER 2 DECADES RECURRING AREAS WITHIN OUR COMMUNITY ARE EXPOSED TO SEWAGE GAS EXTENDING BEYOND MCU FACILITY AND COLLECTION SYSTEM PERIMETERS INTO OAK RUN NEIGHBORHOODS THROUGHOUT OUR COMMUNITY. THIS IS ADVERSELY EFFECTING SENIOR CITIZENS, HEALTH, PROPERTY VALUES AND HOMES DIRECTLY DOWN WIND FROM THE PLANT ARE EXPOSED ON A DAILY BARRAGE OF SEWER GAS RELEASE FROM BIO TANKS AND DISPOSAL DEVICES EXPOSED AND OPEN TO THE ELEMENTS. *INTERIM STEPS PREVIOUSLY AGREED BY MCU HAVE NOT BEEN BEGAN, COMPLETED AND NOW REPORTED DELAYED. RECENT MULTIPLE REPORTS FROM RESIDENTS IN DIFFERENT NEIGHBORHOODS INDICATING SEWER SMELL IS COMING OUT OF DRAINS IN THEIR HOMES.*
